

The design world has its focus firmly on the future with the rapid ascension of 3D printing.



With the escalation of 3D printing capabilities, the architectural and sculptural



CPP-Luxury.com The Wealth Report – 2011: "The report has shown a boost in demand for luxury in key locations, with opinions showing that Mumbai has increased in importance by 118 percent, Shanghai by 91 percent, and Sao Paolo by 66 percent." The current market shift reveals the increasing need to appeal to differing tastes and design ethics from different regions. As Europe is turning back to discretion and minimalism, emerging (and already emerged) economies such as India, Russia, and the UAE are celebrating their newfound status with the accoutrements of their history, culminating in a magnificent blend of ornate Asian opulence and modern European

minimalism - a merging of cultures and an acceptance of both. It is not a cultural clash but rather an intercultural marriage – made possible by the increasing acceptance and tolerance of different cultural backgrounds and the western world's continued reliance on emerging economies. "Even in the West, 'Austerity Fatigue' has set in, and with it the demand for more pleasure per pound, dollar, or euro." (Viewpoint No. 31) The overall look is at once decadent and demure - feminine and serene. A profusion of ornaments, jacquards, prints, historical and decorative motifs, from both east and west merge to inspire a new breed of glamorous jet setters.
















## THE MOOD



#### BIOGRAPHY

Originally a sculptor and a graduate of les Beaux Arts, Philippe Audibert explored many different areas of fashion before specializing in jewelry. His unique knowhow expresses his desire to combine his love for art and his passion for accessories. Thus his elastic cuffs have quickly become the signature of his large collections, whose bracelets, rings, and

necklaces are worn like true ready-to-wear masterpieces.

STYLE DESCRIPTION Classic

The Classic theme is based on ambiguity and hybridity. The collar shape of this necklace is inspired by Ancient Egypt and the Pharaohs, and gives the piece a masculine edge. The bold square-cut Fancy Stones and geometric detailing hint at ancient armor to create a strong and futuristic piece for the modern woman.

#### Romantic

This piece tells the story of an eclectic romance, inspired by bohemian traditions, representing the wild and independent woman. We find both an ornamental and opulent side, sweetened by floral patterns. The color palette reinforces the paradox of the piece: both gentle and impressive.

#### Progressive

The Progressive theme is an interpretation of the bone structure of a human arm, with a technical and cuttingedge design. It is inspired by tomorrow's positive future, hence its combination of futuristic shapes and natural colors, which give the jewelry a poetic feel.

## Glamour

This theme brings us to India for a glamorous journey. The jewelry is inspired by Hindu dances as well as the warm and spicy colors of the country. This cuff follows the "more is more" and excess trends, inspired by ostentatious eastern opulence and extravagance, while remaining feminine and sophisticated.
